

### NATIONAL PUZZLE DAY 2009

- (3) The person who wound up working in a small practice was from Tennessee.
- (4) Edward, who did the semester abroad, was not from Tennessee or West Virginia.
- (5) Betty and Francine had competed for a spot on law review, but participated in other activities (Moot Court and the SBA, although not necessarily in that order) when they were not selected.
- (6) The woman from North Carolina, who was friends with the person who participated in the SBA, went to work for the overseas firm.
- (7) Danielle is from Kentucky; she is not the person who is in the solo practice.
