What's New in the Library?

- The Library's "Get REAL!" (Research and Electronic Assisted Learning) training classes continue through February. These short refresher courses are helpful reminders about the legal research process: finding cases, finding statutes, finding law review articles, and finding updates using citators. Stop by the Reference Desk on Wednesday afternoons at 4:15 (schedules are posted around the Library and on our web site).
- Both Lexis and Westlaw will be stopping by in February to run their popular certification classes. These sessions will give you more experience using the two online legal databases, and teach you the tips and tricks you may need during your externship and your future practice. Although these schedules are tentative, we expect Lexis the week of February 11, and Westlaw the week of February 18. We'll have signup sheets at the Circulation Desk as soon as the times and dates are confirmed.
- The Library runs a survey every two years, asking students to grade us on our services and our facility. We'll be placing these in your mailbox in mid-February.
 Then while you're all off-campus on some beautiful sunny beach, we'll spend our Spring Break tallying the results and reporting back in a future newsletter.

Other News

- Virginia residents don't have to worry about "Super Tuesday" on February 5 (the date during the election cycle which had the largest number of primaries and caucuses). The Virginia primaries will be held a week later, on February 12.
 - If you were wondering: lawyers are fairly well represented in the current crop of candidates (as of press time). On the Democratic side, Hillary Clinton got her JD at Yale, John Edwards got his JD at UNC Chapel Hill, and Barack Obama got his JD at Harvard. The Republicans have Rudy Guiliani with his JD from NYU and Mitt Romney with his JD from Harvard. Interestingly, *USA Today* noted that the proportion of US presidents who were lawyers fell from 76 percent in the 19th century to 39 percent in the 20th century.
- Another excuse gets thrown out of court "I got stuck in traffic." Toshiba America had fourteen days to file an appeal. The lawyer handling the case wound up passing off the motion to a courier at 3:14 pm on the last day of the filing period knowing that the filing deadline was at 4 pm. The courier encountered "unusually heavy traffic" and a train in Santa Ana, California, and got to the courthouse just after the place had closed. The court had no sympathy: "These circumstances, however regrettable, do not meet the standard for 'excusable neglect.' ... [T]he entirely foreseeable obstacle of traffic in Southern California in the late afternoon ... cannot justify an enlargement of time," especially when "the reason for delay in this case was entirely foreseeable and avoidable."
